Basic Seamanship and Safe Boathandling: Nautical Licence Concession

Transport Malta notifies that further to and in addition to the previously advised concession regarding the Certificates issued by MCAST Maritime Institute in 2017 issued last April, new provisions are being put in place.

With immediate effect and until 31st December 2017, the Certificates of Completion issued by the respective Training Centres in 2017 and duly signed and stamped by Transport Malta examiners, are considered as equivalent to the official Nautical Licence issued by Transport Malta. .

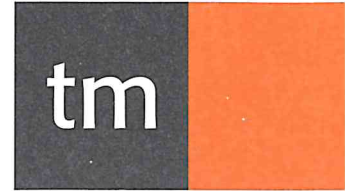
A copy of these Certificates should always be carried on board in lieu of such Nautical Licence. Transport Malta would like to remind all that Certificates issued prior to 2017 are not considered as equivalent to the official Nautical Licence and therefore, such Licence must be immediately applied for.

To apply for a Nautical Licence, the applicant must call personally at the SSR Office and present these Certificates and two recent colour passport-size photos; fill the application form; and pay the applicable fee of €23.29. The Nautical Licence, once issued, will be valid for ten years. Renewal of Nautical Licences can be effected by mail using the Transport Malta self-addressed envelope provided with the renewal notice.

Once processed, the Nautical Licence will be sent to the applicant via registered mail.

Transport Malta would also like to remind all drivers of craft equipped with an engine or engines with a combined power of 30HP or more, must be in possession of a valid Nautical Licence.

Basic Seamanship and Safe Boathandling: Nautical Licence Concession

Transport Malta tavza li wara u b'zieda mal-koncessjoni li giet avzata preċedentement f'April li għadda dwar iċ-Ċertifikati maħruġa mill-Istitut Marittimu tal-MCAST fl-2017, provvedimenti godda sejrin jiġu applikati.

B'effett immedjat u sal-31 ta' Diċembru tal-2017, is-*Certificates of Completion*, li jixhdu li l-kors applikabbi ġie komplut, maħruġa miċ-Ċentri tat-Tahriġ rispettivi fl-2017 u ffirmati u ttimbrati kif suppost mill-eżaminaturi ta' Transport Malta, huma meqjusa bħala ekwivalenti għal-Liċenzja Nawtika maħruġa minn Transport Malta.

Kopja ta' dawn iċ-Ċertifikati għandhom dejjem jinzammu abbord minflok din il-Liċenzja Nawtika. Transport Malta tfakkar illi iċ-Ċertifikati maħruġa qabel l-2017 mhumiex ikkunsidrati bħala ekwivalenti għal Liċenzja Nawtika uffiċjali u għalhekk, għandha ssir applikazzjoni għal-Liċenzja minnufih.

L-applikant għandu jmur personalment fl-Uffiċċju tal-SSR sabiex japplika għal-Liċenzja Nawtika u għandu jipprezenta l-imsemmija Ċertifikati u żewġ ritratti bil-kulur daqs ta' passport; jimla l-formula tal-applikazzjoni; u jhallas il-hlas dovut ta' €23.29. Il-Liċenzja Nawtika, meta maħruġa, hija valida għal għaxar snin. It-tigdid tal-Liċenzja Nawtika jista' jsir ukoll bil-posta permezz tal-envelopp provdut minn Transport Malta mal-avviż tat-tigdid.

Meta tiġi pproċessata, il-Liċenzja Nawtika tintbagħat lill-applikant permezz tal-posta registrata.

Transport Malta tixtieq tfakkar ukoll lis-sewwieqa ta' inġenji tal-baħar, mgħammra b'magna jew b'magni li flimkien għandhom il-qawwa ta' 30HP jew iktar, li għandu jkollhom Liċenzja Nawtika uffiċjali u valida.
