Data Protection Privacy Notice

1. The information we collect and how we use it

- 1.1. From this Application Transport Malta collects different types of information as required by Law and is used explicitly to process your **Application to sit for the Certificate of Competency Examination** in accordance with the Commercial Vessels Regulations, 2002 as amended S.L. 499.23. It is to be noted that if the required information is not provided the said application could not be processed.
- 1.2. 2. To whom we disclose information
