1) Response to this CfQ are to be submitted online through the ePPS (electronic Public Procurement System)<sup>1</sup>.

**2) The General Rules Governing Tendering Version 4.1, found through [www.etenders.gov.mt/Resources](http://www.etenders.gov.mt/Resources) , shall apply in principle to this Call for Quotations.**

3) The Estimated Procurement Value for this Call for Quotations has been based on comprehensive research including appropriate financial analysis. In the context of this procurement, the Estimated Procurement Value, based on market research, is that of €9,990.00 excluding VAT.

The purpose of this value shall be the guidance of prospective bidders when submitting their offer and is not to be considered as a binding capping price.

Therefore, the published Estimated Procurement Value is not restrictive and final on the Contracting Authority. Economic Operators are free to submit financial offers above or below the Estimated Procurement Value. However, the Contracting Authority reserves the right to accept or reject Financial Offers exceeding the Estimated Procurement Value.

##### **1) Purpose**

The purpose of this Call for Quotation (CfQ) is the Supply and delivery of LED floodlighting units 220V-240V / 50HZ, minimum 5800k, 50000lm or above, IP65 or above, Black or Grey body finish, Power minimum 400W.

- **Minimum IP65**
- **Minimum 5800k**
- **Minimum 50000 Lumens**
- **Supply voltage – 220V – 240V / 50Hz**
- **Black or Grey body finish.**
