- Kopja taċ-ċertifikat tal-VAT

Jekk xtrajt pedelec ġdid:

- Fattura;
- Irċevuta fiskali;
- Speċifikazzjonijiet Tekniċi u Dikjarazzjoni/Ċertifikat CE;
- Formola ta' ispezzjoni minn Transport Malta.

HOW TO APPLY FOR AN ELECTRIC VEHICLES GRANT

Are you a person, NGO or business* who bought a new Electric Vehicle and wish to apply for the government grant?

You will need the following:

- eID;
- Bank document showing your IBAN or Bank Account number.

If you scrapped a vehicle:

- The destruction certificate;
- Have the Logbook at hand.

For company and partnerships:

- A copy of the company's registration certificate; and
- The UBO or GSD Certificate from MBR.

For sole-traders:

- A copy of the VAT Certificate.

If you purchased a new pedelec:

- Invoice;
- Fiscal Receipt;
- Technical Specification and CE Declaration/Certificate;
- Transport Malta inspection form.
