Termination, suspension or revocation of the AOC of a air carrier licensed in accordance with Regulation (EC) No 1008/2008 automatically invalidates the present certificate in relation to the aircraft registrations specified in the AOC, unless otherwise explicitly stated by the competent authority.
7. Subject to compliance with the previous conditions, the certificate shall remain valid for an unlimited duration unless the certificate has previously been surrendered, superseded, suspended or revoked.
