- ID card / Passport is required to enter the Examination Room. Examinations are conducted in English.
- All applications and payments are to be received by not later than **8 working days from the date of first exam of each sitting**. Applications and proof of payment to be sent via email to [cadexaminations.tm@transport.gov.mt](mailto:cadexaminations.tm@transport.gov.mt).
- Students are to arrive at the Examination Centre at least 15 minutes before the start time of the exam to follow TM CAD's Invigilator Instructions. Clothing during examinations shall not include any type of head gear, scarves, ties, bulky jackets and large ornaments/necklaces. Candidates may be requested to remove any items which the Invigilator might find unnecessary for the conduct of the examination.

**NOTE: Examination Slots for the sittings will be established by Personnel Licensing Officers. Candidates will be notified by their ATO of the respective date and time of examination.**
