This certificate is granted subject to the following conditions:

- 1. A person authorised by the Director General for Civil Aviation shall have access to any premises in the occupation or control of the holder of this certificate for the purpose of examining the premises and any document, equipment, tools, material or other things of whatsoever nature, relating to the operation of aircraft hereunder kept or used or intended to be used in connection with the operation of the aircraft.
- The holder of this certificate shall furnish to the Director General for Civil Aviation for examination a copy of every LUC manual, related supporting manuals and of all other written instructions in force concerning the operation of the aircraft under this certification and submit any changes for examination.
- Every flight under this certificate shall be conducted in accordance with the provisions of the Company LUC Manual and related procedures and instructions.
- 4. The holder of this certificate shall give to the Director General for Civil Aviation not less than 20 days' notice in writing of any intended change in the nominated person or in their duties.
- 5. The holder of this certificate shall give to the Director General for Civil Aviation immediate notice, in writing, if the Company goes into liquidation, or is placed into receivership or administration.
- 6. The certificate shall remain valid subject to:
  - i. The holder remaining in compliance with the relevant requirements of Regulation (EU) 2019/947 and Regulation (EU) 2018/1139 and its Implementing Acts;
  - ii. Transport Malta Civil Aviation Directorate (TM CAD) being granted access to the holder to determine continued compliance with the relevant requirements of Regulation (EU) 2019/947 and Regulation (EU) 2018/1139 and its Implementing Acts; and
  - iii. The certificate not being surrendered or revoked.
- 7. The certificate may be suspended under the provisions of Chapter 218 of the Laws of Malta.
- 8. Upon suspension, revocation or surrender the certificate shall be returned to TM CAD without delay.
