## **Data Protection Privacy Notice**

#### 1. The information we collect and how we use it

- 1.1. It is to be noted that if the required information is not provided the said application could not be processed.
- 1.2. The primary purpose for collecting information is mainly to process the Sea Service Testimonial for Revalidation of and Existing Certificate of Competency, however, Personal information may also be used for related purposes that amongst other include: sending notifications, and for the provision of information with regards to any legislative amendments which may affect the services offered to you.

#### 2. To whom we disclose information

- 2.1. This information will be solely used for the reasons detailed above. However there may be cases where personal iinformation is shared with the following third parties for reasons listed below;

  - Any law enforcement body who may have any reasonable requirement to access your personal information;
  - Third party entities.
