Section A: Instructions

1) Response to this CfQ are to be submitted online through the ePPS (electronic Public Procurement System)¹.

2) The General Rules Governing Tendering Version 4.1, found through <u>www.etenders.gov.mt/Resources</u>, shall apply in principle to this Call for Quotations.

3) The Estimated Procurement Value for this Call for Quotations has been based on comprehensive research including appropriate financial analysis. In the context of this procurement, the Estimated Procurement Value, based on market research, is that of €9,500.00 excluding VAT.

The purpose of this value shall be the guidance of prospective bidders when submitting their offer and is not to be considered as a binding capping price.

Therefore, the published Estimated Procurement Value is not restrictive and final on the Contracting Authority. Economic Operators are free to submit financial offers above or below the Estimated Procurement Value. However, the Contracting Authority reserves the right to accept or reject Financial Offers exceeding the Estimated Procurement Value.

Section B:

General Information

1) Purpose

The purpose of this Call for Quotation (CfQ) is the Supply, Delivery and Installation of Bridge Bar Sound System for Counters at Transport Malta premises.

2) Beneficiary

The beneficiary, being Transport Malta is the point of contact for this CfQ.

Clarifications shall be uploaded and will be available to view/download from <u>www.etenders.gov.mt</u>

The last date on which the Contracting Authority (CA) shall issue a clarification is four days prior to the closing date of the tender, i.e. 18th March 2021.

3) Scope and Terms & Conditions

The place of acceptance of the supplies and installation shall be at **Transport Malta**, **A3 Towers**, **Triq I-Arkata**, **Paola and Triq Pantar**, **Lija**, the time-limits for the execution of the call shall be two weeks from the Purchase Order date, and the INCOTERM²⁰¹⁰ applicable shall be Delivery Duty Paid (DDP).

Section C

The Contracting Authority is asking interested Economic Operators to submit a response containing, the following information:

3) Response Format and Award Criteria

Responses are to be straightforward, clear, concise and specific to the information requested. In order for submissions to be considered complete, Economic Operators must provide all the requested information mentioned in this document as well as any other comments, observations or suggestions which potentially may assist the Contracting Authority in the Call for Quotations.

The sole award criterion will be the price. The contract will be awarded to the tenderer submitting the cheapest priced offer satisfying the administrative and technical criteria.

Section D

Additional Information

Further to what is stated in the General Conditions, any communication should be addressed to the ICT Directorate, Transport Malta, Triq Pantar, Lija. Formal Lines of communications will then be communicated along with the Official Purchase Order.

Further to the General Conditions, upon delivery, the contractor is to provide copies of the technical manuals and drawings (if applicable) for the bridge bar sound system in the English language.

The warranty shall remain valid for 36 months after provisional acceptance.

Warranty is to cover both parts and labour and any maintenance that may be required.

The contract is to commence on the receipt of the official purchase order.

Further to the provisions of the General Conditions, the Contractor shall bear all risks relating to the supplies until provisional acceptance at destination. The supplies shall be packaged so as to prevent their damage or deterioration in transit to their destination.

Section E

Financial Bid Form

A financial offer calculated on the basis of **Delivered Duty Paid (DDP)**²⁰¹⁰ (Grand Total) for the supplies tendered as per Tender Response Format. ^(Note 3)

Quotations are to be submitted and shall be awarded including taxes/charges and any import duties applicable but excluding VAT.
