Establishment of Mooring Areas and Fairways in Mellieha Bay (Re-issue)

The Ports and Yachting Directorate, Transport Malta, notifies mariners, owners of vessels and the general public that a re-organisation of Mellieha Bay, including fairways and mooring areas (Zones A, B, C, D, L, M and N) (as shown in the attached chart) have been established as follows:

A buffer-safety zone of 20 meters has been established at the end of the swimming zone area (as per Local Notice to Mariners 60 of 2025). All mariners must always keep this area clear at all times.

Mooring areas reserved for water sports and commercial vessels have been identified at the end of the buffer-safety zone as per areas 1,2,3 and 4 (as shown in the attached chart).

All fairways (and Launch lanes) in between the above-mentioned areas must be clear at all times. All mariners and vessel owners are reminded of their obligations to ensure safety at sea, which includes being aware of their location and ensuring that fairways are kept clear unless they are navigating.

In view of this, all mariners and vessel owners are to ensure that they have the correct navigational equipment on board, including paper charts or alternative digital means of navigation and/or a dedicated ENC or equivalent, which may also include the use of navigational applications on their smartphones or tablets, that would allow them to ascertain their exact location.


Mooring holders will be contacted in the coming days in the interest of clarifying related procedures and on this note we highlight the importance to mooring holders to ensure coordinates and procedures provided by the Yachting & Mooring department are complied with.

To always ensure safety, the use of fishing gear and related ancillary is not allowed in these areas.

In view of the above, mariners navigating in the area are to navigate with caution and at safe speed (no wake) and in line with speed limits established in the area. They are to comply with the instructions as communicated by the Valletta Port Control (VTS) on VHF Channel 12 or by the Authority's officials or other Enforcement Agencies.
