Solemn Declaration made today the _____, requesting the Temporary Registration of a Motor Vehicle.

I, the undersigned, _____, holder of ID Card / Passport number _____. And residing at _____, appearing hereon in my own name and on my own behalf as well as on behalf of _____ Company with C_____ and registered address at _____, do hereby solemnly and under oath declare that:

I am submitting hereby my request to the Land Transport Directorate, within Transport Malta, for the registration of the motor vehicle having Chassis number _____ as a temporary registered vehicle. I will re-export the said vehicle within ninety days from when the same is registered temporarily in virtue of Section 17A of the Motor Vehicle Registration Tax Act, which ninety day period is hereinafter referred to as the "Temporary Registered Period".

I understand that the submission of this declaration to the Land Transport Directorate does not, in itself, constitute the temporary registration of the said vehicle. Upon favorable consideration of this request by the Authority and the payment of a registration tax of €235.00, a certificate of temporary registration will be issued.

I understand that, in terms of the Motor Vehicles Registration Tax Act, the vehicle must be re-exported within the Temporary Registration Period. Prior to the expiration of the Temporary Registration Period, I must provide all the documentary evidence requested by the Authority to prove that the vehicle has in effect been re-exported. Furthermore, within twenty days from the expiration of the Temporary Registration Period, I must deliver to the Authority the number plates relative to the said vehicle.

Furthermore, I understand that in the event that the vehicle is not in fact re-exported within the Temporary Registration Period or if I fail to supply the requested evidence referred to in the last preceding paragraph, I shall become liable to pay an additional tax. This additional tax shall be equivalent to the amount of tax due for the permanent registration of the vehicle in accordance with The Motor Vehicle Registration Tax Act as at the last day of the Temporary Registration Period.

I also understand that in the event that following the re-exportation of the vehicle, the said vehicle is again imported into Malta, an additional tax shall be due. This additional tax shall be equivalent to the amount of tax due for the permanent registration of the vehicle in accordance with The Motor Vehicle Registration Tax Act as at the date of re-importation.

I also understand that in accordance with The Motor Vehicle Registration Tax Act, should I do or omit, or suffer to be done or omitted any act or thing with the intent of unlawfully evading or postponing the payment of vehicle registration tax, I shall be guilty of a CRIMINAL OFFENCE and upon conviction shall become liable to:

- i. A fine not exceeding €2,500, or twice the amount of the tax endangered, depending on whichever is the greater,
or
- ii. Imprisonment for a term not exceeding six months, or
- iii. Both such fine and imprisonment.

I understand that compliance with the obligations outlined herein does not exonerate me from any other obligation arising out of any law applicable in Malta from time to time.
