Data Protection Privacy Notice

The information we collect and how we use it

- 3.3. At any time, you may object to the processing of your Personal Data, on legitimate grounds, except if otherwise permitted by applicable law.
- 3.4. In accordance with Applicable Law, we reserve the right to withhold personal data if disclosing it would adversely affect the rights and freedoms of others. Moreover, we reserve the right to charge a fee for complying with such requests if they are deemed manifestly unfounded or excessive.

Retention period

Personal data will be retained for not more than 3 months from date of application should the application not be submitted complete or is rejected.
