**RESTRUCTURING OF THE MARITIME SECURITY (PORTS) DEPARTMENTS AT  
AUTHORITY FOR TRANSPORT IN MALTA**

---

As part of an ongoing exercise to improve the Authority's capability to deliver its regulatory obligations in terms of law and to better support the maritime industry as it evolves, the following changes in Maritime Security and Compliance at Transport Malta shall be implemented.

With immediate effect the Office of the statutory national Port Security Officer (PSO), as stipulated in the local *Subsidiary Legislation 499.35; Ports Security Regulations* and the *Dir.2005/65/EC*, shall be under the direction of Prof. David Attard, who is appointed as *Director for Maritime Security Compliance & Monitoring Department (Ports) & PSO - National MARSEC Audit & Inspectorate for Ports, Port Facilities & Domestic Shipping (Chairman's Office)*.
