### Installation of Snorkeling Trail at Ir-Ramla tal-Mixquqa and at Ir-Ramla ta' Ghajn Tuffieha

The Ports and Yachting Directorate, Transport Malta notifies mariners and owners of vessels that two snorkelling Trails are set out at Ir-Ramla tal-Mixquqa and Ir-Ramla ta' Ghajn Tuffieha.

The snorkelling trail consists of poles with informative signs attached, which will be fixed to the seabed allowing snorkelers to follow the trail. Some of these poles will be less than 1 meter below the sea surface.

In view of the above mariners and owners of vessels are being advised that two "Entry Prohibited" areas are being established.

Ir-Ramla tal-Mixquqa, the area bounded by the points A, B, C, D and the intermediate coastline (shown hatched on attached chart 1)




