## Filming at various localities - The Dive

The Ports and Yachting Directorate, Transport Malta notifies all mariners and owners of vessels, that filming activities will take place in different localities around Malta as shown on the attached charts.

The filming will be held as follows:

At II-Ponta tat-Tumbrell within the area as shown on chart A, between 0700 hours and 1800 hours on the following days.

Friday 27th August 2021, Saturday 28th August 2021, Monday 30th August 2021, Tuesday 31st August 2021 and Wednesday 1st September 2021.

At Ras il-Griebeg (Il-Bajja tal-Mellieħa) within the area as shown on chart B, on Thursday 2nd September 2021 between 0700 hours and 1100 hours.


At II-Ponta tal-Qawra within the area as shown on chart C, on Thursday 9th September 2021 between 0700 hours and 1700 hours.

Mariners and owners of vessels are informed that a clear horizon is being requested, therefore no vessel will be allowed to drop anchor or remain underway in the vicinity of the respective areas, whilst filming is taking place.

Mariners navigating in the vicinity of the indicated areas on the mentioned dates and times are requested to keep watch on VHF Channel 12 and/or 16 and are to cooperate with the filming crew and/or enforcement personnel in the area.


Any instructions issued on VHF channel 12 and/or 16 by Valletta VTS are to be complied with.


