Works in progress outside II-Magħluq in II-Bajja ta' Marsaxlokk

The Ports and Yachting Directorate, Transport Malta notifies Mariners that a 'works in progress' areas will be established outside II-Magħluq in II-Bajja ta' Marsaxlokk.

The works are expected to start with immediate effect and are to be completed by Saturday 14th August 2021.

The areas will be delineated by the imaginary lines, one joining the points A, B, C, D and the intermediate coastline and the other joining the points E, F, G, H and the intermediate coastline, as shown on attached chart.


Divers will assist in the works and shall be displaying the International Code of Signals flag "A".

Marker buoys will be placed at points B, C, F and G.
