Coastal rowing beach sprint at Ir-Ramla tal-Mixquqa

The Ports and Yachting Directorate, Transport Malta, hereby notifies that the University of Malta Rowing Club will be organising a coastal rowing club beach sprint at Ir-Ramla tal-Mixquqa.

The activity will be held on Monday 24th April 2023 between 1000 hours and 1600 hours and on Tuesday 25th April 2023 between 1200 hours and 1630 hours, within the area A, B, C and D, as shown on attached chart A.



All mariners are to comply with any instructions given on VHF Channel 12 and/or 16, by Valletta VTS and by any Enforcement Personnel on site.


