Swimming part of an event from Cirkewwa to Valletta

The Ports and Yachting Directorate, Transport Malta, notifies mariners that a swimming / running event will be held on Saturday 3rd June 2023 from Cirkewwa to Valletta. There will be safety boats in each individual swim at all times.

The swimming part of the event will follow the route (as shown on the attached charts) and will be as follows:

| Swim between points | | Start and finish time of the individual swim |
|---------------------|---------|--|
| from A to B | chart 1 | 1010 hours and 1110 hours, |
| from C to D | chart 2 | 1125 hours and 1200 hours, |
| from E to F | chart 3 | 1210 hours and 1300 hours, |
| from G to H | chart 4 | 1330 hours and 1405 hours, |
| from I to J | chart 4 | 1355 hours and 1430 hours and |
| from K to L | chart 5 | 1425 hours and 1510 hours. |

If the event cannot be held on the above-mentioned date, they will try to hold the event either on Saturday 10th June 2023 or Saturday 17th June 2023, along the same route and at the same times.

Mariners are advised to keep a sharp lookout and navigate at slow speed, they are to keep well clear of the areas during the stipulated date and times, giving the swimmers and support vessels a wide berth.

Mariners are to comply with instructions issued on VHF channel 12 and/or 16 by Valletta VTS and by any Enforcement Personnel on site.




