AMENDMENT TO THE MARITIME PILOTAGE TARIFFS

As advised in Port Notice 10 of 2007 issued on 21st December 2007, the Agreement entered into in 2007 between the then Malta Maritime Authority (today the Authority for Transport in Malta) and the Malta Maritime Pilots Co-operative Society Limited establishes that a 7% increase in the standard rates for pilotage services shall take place every four years.

In this respect, the next revision in the standard tariff will be effective as from 1st January 2024.

The relative Legal Notice amending the Schedule to the Maritime Pilotage Regulations (S.L. 499.26) will be published accordingly.

Enclosed with this Port Notice are the revised rates.
