#### **Data Protection Privacy Notice**

The Authority for Transport in Malta, Transport Malta of Triq Pantar, Lija, Malta, LIA 2021 is the Data Controller for the purpose of the Data Protection Act CAP 586 and the General Data Protection Regulation (EU) (GDPR) 2016/679. ### 1. The information we collect and how we use it

- 1.1.
