- Be the registered owner of a passenger transport vehicle<sup>3</sup> which has been equipped with approved photovoltaic panels;

#### GRANT DETAILS

Subject to the scheme conditions, a grant amount equal to **80% of the investment cost** required for the installation of approved photovoltaic panels shall be issued to the registered owners of the vehicles, without exceeding:

- €1,000 in the case of a Category M3 (Coach), N3 (Trucks) and O4 (Semi/Trailers) Vehicles ; OR
- €500 in the case of a Category M2 (Minibuses), N2 (Small Trucks) and O3 (Small Semi/Trailers) Vehicles.

Applicants are entitled for a maximum of 10 grants.

## Data Protection Privacy Notice

The Authority for Transport in Malta (Transport Malta) of Triq Pantar, Lija, Malta, LJA 2021 is the Data Controller for the purpose of the Data Protection Act CAP 586 and the General Data Protection Regulation (EU) (GDPR) 2016/679. ### 1. The information we collect and how we use it

- 1.1. From this Application Transport Malta collects different types of information which information is that required by Law and is used explicitly for your applications. It is to be noted that if the required information is not provided the said application could not be processed.
- 1.2.
