Further to Local Notice to Mariners No 037 of 2021 regarding Designated Restricted Areas

The Ports and Yachting Directorate, Transport Malta notifies mariners, owners of vessels and the general public that further to Local Notice to Mariners No 037 of 2021 regarding Designated Restricted Areas, the following areas have also been established as a designated restricted areas to navigation:

1) In Marsamxett Harbour (Ta' Xbiex area), the area joining the points 1A, 1B, 1C, 1D and the intermediate coastline as shown on attached chart 1.

2) In Marsamxett Harbour (Valletta Water Polo Pitch area), the area joining the points 2A, 2B, 2C and the intermediate coastline as shown on attached chart 2.

3) In the Grand Harbour (Rinella Bay area), the area joining the points 3A, 3B and the intermediate coastline as shown on attached chart 3.

| Points | Latitude (N) | Longitude (E) |

| 3B | 35º 53'.584 | 014º 31'.609 |

4) In the Grand Harbour (Kalkara Creek – Toqba area - Birgu), the area joining the points 4A, 4B, 4C, 4D and the intermediate coastline as shown on attached chart 4.

| Points | Latitude (N) | Longitude (E) |
|--------|--------------|---------------|
| 4A | 35º 53'.450 | 014º 31'.225 |
| 4B | 35º 53'.452 | 014º 31'.228 |
| 4C | 35º 53'.418 | 014º 31'.271 |

These designated restricted areas shall be in place with immediate effect until Thursday 30th September 2021. They will be delineated by rope which will be kept afloat by coloured marker floats and may be left in location up to 2 weeks after the closing date.

All the information and restrictions mentioned in Local Notice to Mariners No 037 of 2021 will also apply to this area.
