### Mellieħa Bay re-organisation of moorings (re-issued)

The Ports and Yachting Directorate, Authority for Transport in Malta notifies all mariners that Mellieħa Bay re-organisation of moorings will commence on Monday 9th June 2025 and it is estimated to take around two weeks to complete.

A commercial vessel/s will be engaged by the Authority to initiate the project. All vessels are requested to maintain a safety distance of 100m.

The Maritime Enforcement Unit will be assisting during the operation.

Owners of vessels which are currently moored within the bay of Mellieħa (as shown in the attached chart) are to remove their vessel from its mooring by 2359 hours of Sunday 8th June 2025.

The limits of Area are as follows;-

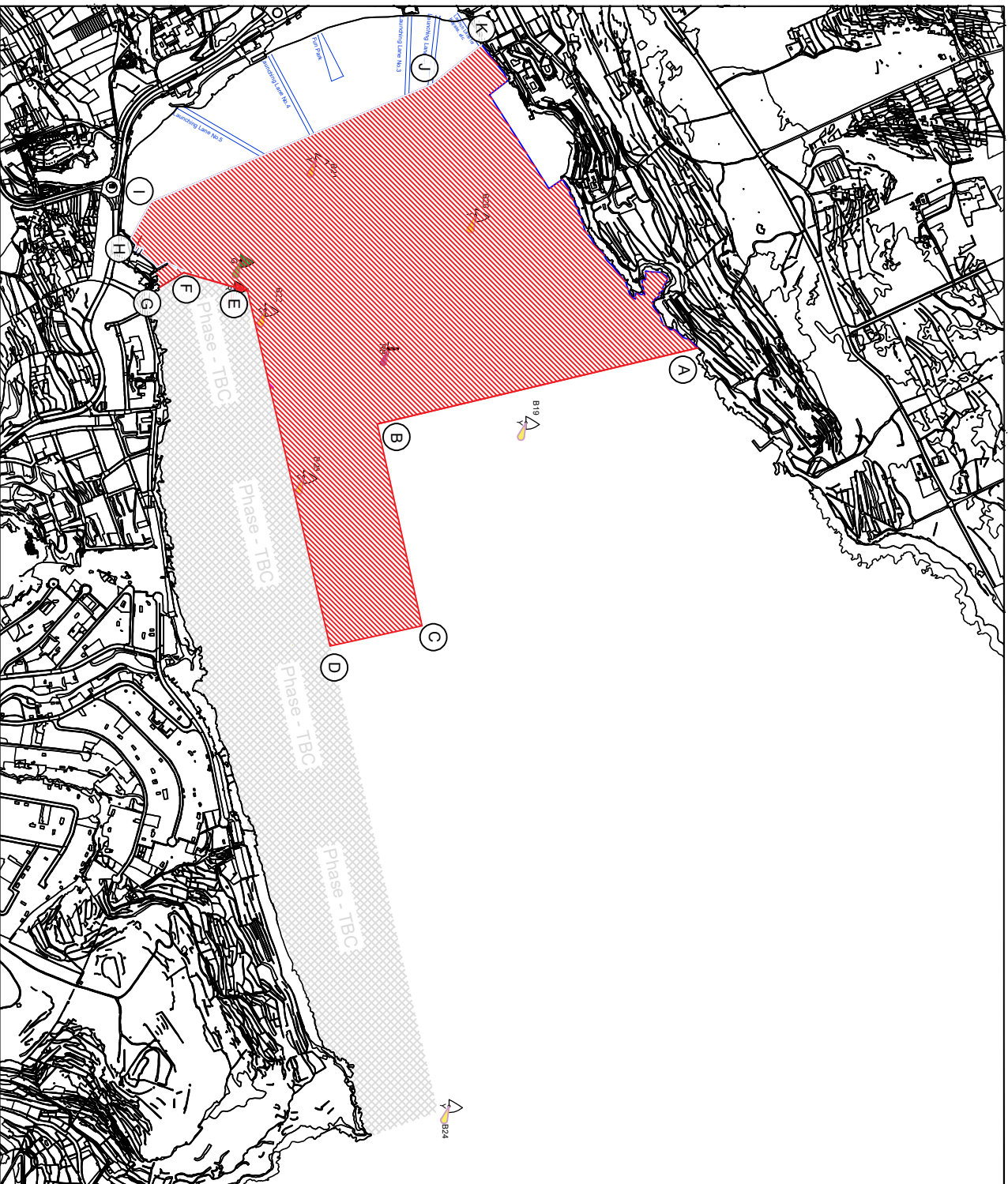

They are to give the above area a wide berth and comply with the instructions as communicated by the Valletta VTS on VHF Channel 12 and/or 16 and by the Authority's officials or other Enforcement Agencies.
