Water sports activities in various bays in Gozo

The Ports and Yachting Directorate, Transport Malta notifies that Otters ASC will be organising water sports activities in various bays in Gozo.

A water polo pitch will be set up on the day of the activities between 0900 hours and 1200 hours (as shown on attached charts) and the activities will be held within the pitch.

The activities will be held as follows:

Xlendi (Chart A)	on Saturday 31 st July and Sunday 1 st August 2021
Daħlet Qorrot (Chart B)	on Saturday 7 th August and Sunday 8 th August 2021
Ħondoq ir-Rummien (Chart C)	on Saturday 21 st August and Sunday 22 nd August 2021
Dwejra – Inland Sea (Chart D)	on Saturday 28 th August and Sunday 29 th August 2021
Mġarr ix-Xini (Chart E)	on Saturday 4 th September and Sunday 5 th September 2021
Marsalforn (Chart F)	on Saturday 11 th September and Sunday 12 th September 2021

Mariners are advised to keep a sharp lookout and navigate with extreme caution and at slow speed (no wake) when in the vicinity, on the stipulated date. They are to cooperate with the organisers and when the pitch is not located inside a swimmer zone, all mariners are to keep a safe distance.

All mariners are to comply with any instructions given on VHF Channel 12 and/or 16, by Valletta VTS and by any Enforcement Personnel on site.
