Filming between the Southern Part of Gozo and the Northern Part of Malta – Jetski

The Ports and Yachting Directorate, Transport Malta, notifies all mariners and sea vessel operators that filming activities will take place between the southern part of Gozo and the northern part of Malta.

Filming will start on Monday 12th October 2020 and should be completed by Tuesday 10th November 2020, between 0700 hours and 1800 hours daily.

A clear horizon is requested from where filming is being carried out at the time, in either of the following locations: (as shown on attached chart 1)

Point A – Ras in-Niexfa Point B – II-Bajja taċ-Ċirkewwa Point C – Ras il-Qala Point D – II-Bajja tal-Mellieħa

A clear horizon and vessels removed is requested from where filming is being carried out at the time, in either of the following locations:

II-Bajja tar-Ramla tal-Bir (shown hatched on attached chart 2) II-Bajja ta' Ghajn Tuffieha (shown hatched on attached chart 3).

Weathering permitting the filming at II-Bajja tar-Ramla tal-Bir will be carried out on Thursday 29th October 2020, while the filming at II-Bajja ta' Ghajn Tuffieha will be carried out on Friday 30th October 2020.

Mariners are requested to keep a sharp look out and navigating at slow speed, in the vicinity of the above areas. They are to cooperate with the organisers and Maritime Enforcement officers in the area.

Moreover, they are to obey any instructions given by Valletta Port Control (Valletta VTS) on VHF Channel 12.
